QDT - 1 through QDT - 7

All instances of the "Land, Building and Fixed Equipment" category in the Research and Development Special Analysis tables should be replaced with the category "Construction of R&D Facilities." On pages QDT - 2, 3, 5, 6, and 7, this change only affects the name of the category; values are identical to the amounts presented in the former category.

<u>QDT – 1</u>

In the Research and Development Special Analysis table, the "Land, Building, and Fixed Equipment" line is changed: the name of the line is now "Construction of R&D Facilities".

- The FY 2013 Actual and Total column values are \$10.56 million; the correct amount is \$207.05 million.
- The FY 2014 Estimate is \$10.80 million, and the correct amount is \$210.80 million.
- The FY 2015 Request is \$10.81 million, and the correct amount is \$211.57 million.

Additionally, the amounts on the Major Equipment line were affected by this change and therefore were misstated.

- The FY 2013 Actual and Total were both \$362.06 million, and the correct amounts are both \$165.57 million.
- The FY 2014 Estimate is \$377.38 million, and the correct amount is \$177.38 million.
- The FY 2015 Request is \$376.64 million, and the correct amount is \$175.88 million.

<u>QDT – 4</u>

The "Land, Building, and Fixed Equipment" line in the Major Research Equipment and Facilities Construction table also changed title to "Construction of R&D".

- The FY 2013 Actual and Total are listed as zero and the correct amount is \$196.49 million.
- The FY 2014 Estimate is given as zero and the correct amount is \$200.00 million.
- The FY 2015 Request is zero and the correct amount is \$200.76 million.

Additionally, the amounts on the Major Equipment line are affected by this change and therefore were misstated.

- The amount for FY 2013 Actual and Total were both \$196.49 million, and the correct amount for both is zero.
- The FY 2014 Estimate is \$200.00 million, and the correct amount is zero.
- The FY 2015 Request is given as \$200.76 million and the correct amount is zero.

The above changes are a result of a reclassification of funding for the Major Research Equipment and Facilities Construction account. It was previously classified in the Research and Development Special Analysis as Major Equipment. The account is now classified in Construction of R&D Facilities category.
