

Graduate Research Fellowship Program Certification Pages

Certification for Authorized Organizational Representative (or Equivalent)

By signing the Certification Pages, the Authorized Organizational Representative is: (1) certifying that statements made herein are true and complete to the best of his/her knowledge; and (2) agreeing to accept the obligation to comply with NSF award terms and conditions. Further, the applicant is hereby providing certifications regarding conflict of interest (when applicable), drug-free workplace, debarment and suspension, lobbying activities (see below), nondiscrimination, flood hazard insurance (when applicable), responsible conduct of research, organizational support, Federal tax obligations, unpaid Federal tax liability, and criminal convictions as set forth in the *NSF Proposal & Award Policies & Procedures Guide* (PAPPG), Chapter II.D.2.a. Willful provision of false information in this application and its supporting documents or in reports required under an ensuing award is a criminal offense (U. S. Code, Title 18, §1001).
