Dear Darlene Booker,

The National Science Foundation (NSF) has completed the review and resolution of the Office of Inspector General (NSF OIG) audit report on costs incurred under NSF awards by University of North Carolina, Charlotte (UNCC) dated February 3, 2023.

The audit report questioned a total of \$6,048 in costs claimed under NSF awards and recommended that UNCC strengthen its administrative and management controls for the areas in which findings were identified. As a result of its resolution efforts, NSF has determined \$6,048 will be disallowed. The table below summarizes the resolution of each finding by recommendation:
