Dear Jonathan Tucker & Nan Lomax,

The National Science Foundation (NSF) has completed the review and resolution of the NSF Office of Inspector General (NSF OIG) audit report on costs incurred under NSF awards by Mississippi State University (MSU) dated January 26, 2024.

The audit report questioned \$34,314 in costs claimed under NSF awards and recommended that MSU strengthen its administrative and management controls for the areas in which findings were identified. As a result of its resolution efforts, NSF sustains all the findings and recommendations and has determined that \$34,314 will be disallowed. The table below summarizes the resolution of each finding by recommendation:
