Life and Environments Through Time (LET)

## **Synopsis of Program:**

The Life and Environments Through Time (LET) program supports research that advances knowledge about the patterns and processes relating to the origin and evolution of Earth's climate, environments, life, and sedimentary record. This research takes place at the molecular, local, regional, and global scales from the Archean Eon through the Holocene epoch. LET-supported research can be useful for predicting and planning for future global change, and for the maintenance and security of ecosystem services and human societies.

## **Broadening Participation In Stem:**

NSF recognizes the unique lived experiences of individuals from communities that are underrepresented and/or underserved in science, technology, engineering, and mathematics (STEM) and the barriers to inclusion and access to STEM education and careers. NSF highly encourages the leadership, partnership, and contributions in all NSF opportunities of individuals who are members of such communities supported by NSF. This includes leading and designing STEM research and education proposals for funding; serving as peer reviewers, advisory committee members, and/or committee of visitor members; and serving as NSF leadership, program, and/or administrative staff. #### I. Introduction

The Life and Environments through Time (LET) Program is part of the Division of Earth Sciences (EAR) within the Directorate for Geosciences (GEO). EAR supports investigations of the evolution, processes, and properties of Earth through this and three other programs:

- Chemical Evolution of the Solid Earth and Volcanology
- Structure and Physics of the Solid Earth
- Water, Landscape, and Critical Zone Processes.

EAR also provides support for instrumental and observational infrastructure, cyberinfrastructure, and educational and outreach activities. Projects may employ any combination of field, laboratory, and computational studies with observational, theoretical, or experimental approaches.

Interdisciplinary and multidisciplinary proposals may require joint review within EAR, GEO, or other NSF Directorates, and may be considered for joint support. Projects should be submitted to the solicitation most strongly aligned with the primary objectives or hypotheses regardless of methods.

EAR invites submission of collaborative projects that articulate a fundamental overarching Earth Science question that is addressed through integrative hypothesis- or question-driven research. The project also should lead to outcomes that have potential to reveal new principles underlying the function or interaction of Earth systems.

## **II. Program Description**

LET projects address research questions by integrating geobiology, geochemistry, paleobiology, paleoecology, sedimentology, and sedimentary geology archives, proxies, techniques, and concepts. LET welcomes projects that challenge the conceptual bases, have broad implications, and inform future research directions on these disciplines.

Examples of topics within the broad scope of LET include scientifically and societally relevant areas of interest. These include but are not limited to:

- Patterns and processes related to the origin, ecology, and evolution of life on Earth.
- Biological, geochemical, mineralogical, sedimentological, and geological processes responsible for forming and shaping the Earth's sedimentary lithosphere and its materials.
- Paleoclimate, climate proxy, and model-based studies advancing knowledge of the drivers, mechanisms, and feedback systems of Earth's climate.
- Development of geochemical and geobiological proxies, tools, methods, and models that will advance the understanding of life and environments through time.
- Biological, geochemical, and physical processes through which critical minerals and materials are mobilized, concentrated, and separated.
- Research that aims to better understand geohealth and the effects of environmental pollution, geochemical exposures, and climate change on human health and well-being.
- Research on bioeconomy to address regional or global societal challenges such as climate change, carbon sequestration, bioremediation, and environmental sustainability.
- Studies on conservation paleobiology to advance knowledge on environmental and human drivers of ecological change.
- Studies of geological hydrogen that advance knowledge on geochemical and microbial processes that stimulate or enhance hydrogen production from geological materials and reservoirs.

Proposals with research that crosses programmatic or cluster boundaries at the U.S. National Science Foundation (NSF) are welcomed and encouraged. Principal Investigators (PIs) are encouraged to contact the cognizant program directors before submission of proposals that may cross program boundaries. LET commonly co-reviews proposals with other NSF programs, sections, and clusters. Within the Geosciences Directorate, common co-review partners include EAR's Water, Landscapes, and Critical Zone (WaLCZ) and Infrastructure programs, the Division of Ocean Science's Marine Geosciences and Ocean Sections, and all programs within the Office of Polar Programs. Proposals on scientific research with environmental and industrial applications can be co-reviewed with the Environmental Engineering and Sustainability Cluster of the Directorate for Engineering. LET also commonly co-reviews with Clusters in the Division of Environmental Biology in the Directorate for Biological Sciences, and with the Biological Anthropology Program within the Directorate for Social, Behavioral, and Economic Sciences.

Proposals for community workshops that can guide the community on new research topics and grand challenge questions are encouraged, and those that have plans to broadly disseminate the discussions and outcomes will be prioritized.

The LET Program supports a wide range of broader impacts activities. These broader impacts activities should be developed within the context of the people involved in the project and the mission, goals, and resources of the organizations involved. The expertise of the collaborators, the proposal budget, and budget justification should reflect this integration. Examples of activities that may be proposed include, but are not limited to, broadening participation in the geosciences, scientific infrastructure enhancement, public engagement, establishing new or expanding partnerships with industry, government, academic, and international institutions, and translating research to benefit broader societal needs.

In addition to opportunities described in this LET solicitation, LET also funds proposals submitted in response to the Faculty Early Career Development (CAREER) Program, Research Coordination Networks (RCN), EMpowering BRoader Academic Capacity and Education (EMBRACE) Program and Mid-Career Advancement (MCA) solicitations. The LET Program also accepts Rapid Response Research (RAPID), EArly-concept Grants for Exploratory Research (EAGER), Planning, and Conference proposal requests (see guidance in Chapter II.F of the PAPPG) and supplemental funding requests requests (see guidance in Chapter VI.E of the PAPPG); these additional proposal submissions require approval from an LET program director prior to preparing a submission. Where LET participates in cross-agency competitions, such as the Paleo Perspectives on Present and Projected Climate (P4CLIMATE) competition, proposals that are suitable for review within these competitions must be submitted directly to these solicitations rather than to LET. If there is doubt as to the appropriate destination for a proposal, prospective PIs are encouraged to contact the LET program directors prior to submission. LET welcomes inquiries on any proposal type prior to submission.

Collaborative Proposals. All collaborative proposals submitted as separate submissions from multiple organizations must be submitted via Research.gov. PAPPG Chapter II.E.3 provides additional information on collaborative proposals.

See PAPPG Chapter II.D.2 for guidance on the required sections of a full research proposal submitted to NSF. Please note that the proposal preparation instructions provided in this program solicitation may deviate from the PAPPG instructions.

**Nature of collaborations:** Pls are required to articulate their plans to ensure mutually beneficial intellectual and educational collaborations with all individuals and organizations involved in the proposed project. The nature of the collaboration should be addressed in the Project Description or in a one-page letter of collaboration uploaded to Special Information & Supplementary Documents. For the purposes of this solicitation letters of collaboration can be up to one page in length and can contain information on capabilities of laboratories, samples to be exchanged, or other details critical to the evaluation of the proposal.

**Undergraduate student mentoring plan:** Pls are required to include a mentoring plan for any undergraduate students involved in the proposed project. The undergraduate student mentoring plan should be addressed in a one-page document uploaded to Special Information & Supplementary Documents.

**Field safety protocols:** If the proposed project includes field work (i.e., research, education, or outreach activities in a natural environment outside of a classroom, laboratory, library, museum, office, or workplace), PIs are required to include information on the protocols that will be undertaken to ensure the physical and psychological safety of all participants. Field safety protocols should address potential hazards and risks of the field areas in the proposed work, e.g., dangerous, remote, or unpredictable conditions; societal discrimination; U.S. State Department Travel Advisories; and participants who may not have experience working under conditions that can be, at times, uncomfortable, unfamiliar, or threatening. Field protocols should incorporate leading practices. This field safety protocol is separate from and in addition to the certification for "Safe and Inclusive Working Environments for Off-Campus or Off-Site Research" described in in Chapter II.E of the PAPPG. The field safety protocol should be uploaded as a 1-page document in the Special Information & Supplementary Documents section. The scale of the protocol can and should scale with the scope of the proposed activities.

**Permits:** If formal approvals (e.g., licenses, permits, authorizations, or agreements) are necessary to undertake the proposed activities, PIs are required to describe in the Project Description how those requirements will be addressed and to document any approvals in the Special Information and Supplementary Documents, as appropriate. Such information may include authorizations from international, federal, state or local authorities, or permissions that are legally required to collect, destroy (as applicable), import, and export samples, instrumentation, and data. Failure to obtain the appropriate permits and approvals for all aspects of the research effort may jeopardize not only the proposed research, but also the well-being of the personnel.

**Data and Sample Management Plans:** Principal investigators (Pls) are required to adhere to the <u>EAR Division Data Management and Sharing Guidance</u> available on the NSF website.

**RAPID proposals:** As outlined in Section II, the LET Program accepts RAPID proposals. PIs are required to discuss RAPID proposal budget requests with a Program Director before submission. PIs are required to discuss RAPID proposal budget requests with a Program Director before submission. Generally, RAPID proposals submitted to EAR programs support costs associated with collection of perishable data that requires a rapid response and do not support PI salary, student tuition, or student salaries beyond the period of urgent data collection. RAPID proposals submitted to EAR programs must include a plan for providing data and samples to the community in an efficient manner and as close to the time of collection as is practicable.

Investigators planning on submitting an EAR research proposal with a significant equipment budget are encouraged to discuss these plans with the relevant research program officer prior to submission.

**Submitting the Proposal:** Once all documents have been completed, the Authorized Organizational Representative (AOR) must submit the application to Grants.gov and verify the desired funding opportunity and agency to which the application is submitted. The AOR must then sign and submit the application to Grants.gov. The completed application will be transferred to Research.gov for further processing.

## **VI. NSF Proposal Processing And Review Procedures**

Proposals received by NSF are assigned to the appropriate NSF program for acknowledgement and, if they meet NSF requirements, for review. All proposals are carefully reviewed by a scientist, engineer, or educator serving as an NSF Program Officer, and usually by three to ten other persons outside NSF either as *ad hoc* reviewers, panelists, or both, who are experts in the particular fields represented by the proposal. These reviewers are selected by Program Officers charged with oversight of the review process. Proposers are invited to suggest names of persons they believe are especially well qualified to review the proposal and/or persons they would prefer not review the proposal. These suggestions may serve as one source in the reviewer selection process at the Program Officer's discretion. Submission of such names, however, is optional. Care is taken to ensure that reviewers have no conflicts of interest with the proposal. In addition, Program Officers may obtain comments from site visits before recommending final action on proposals. Senior NSF staff further review recommendations for awards. A flowchart that depicts the entire NSF proposal and award process (and associated timeline) is included in PAPPG Exhibit III-1.

Proposers should also be aware of core strategies that are essential to the fulfillment of NSF's mission, as articulated in <u>Leading the World in Discovery and Innovation, STEM Talent Development and the Delivery of Benefits from Research - NSF</u>
<u>Strategic Plan for Fiscal Years (FY) 2022 - 2026</u>. These strategies are integrated in the program planning and implementation process, of which proposal review is one part. NSF's mission is particularly well-implemented through the integration of research and education and broadening participation in NSF programs, projects, and activities.

One of the strategic objectives in support of NSF's mission is to foster integration of research and education through the programs, projects, and activities it supports at academic and research institutions. These institutions must recruit, train, and prepare a diverse STEM workforce to advance the frontiers of science and participate in the U.S. technology-based economy. NSF's contribution to the national innovation ecosystem is to provide cutting-edge research under the guidance of the Nation's most creative scientists and engineers. NSF also supports development of a strong science, technology, engineering, and mathematics (STEM) workforce by investing in building the knowledge that informs improvements in STEM teaching and learning.

NSF's mission calls for the broadening of opportunities and expanding participation of groups, institutions, and geographic regions that are underrepresented in STEM disciplines, which is essential to the health and vitality of science and engineering. NSF is committed to this principle of diversity and deems it central to the programs, projects, and activities it considers and supports.

## A. Merit Review Principles and Criteria

The National Science Foundation strives to invest in a robust and diverse portfolio of projects that creates new knowledge and enables breakthroughs in understanding across all areas of science and engineering research and education. To identify which projects to support, NSF relies on a merit review process that incorporates consideration of both the technical aspects of a proposed project and its potential to contribute more broadly to advancing NSF's mission "to promote the progress of science; to advance the national health, prosperity, and welfare; to secure the national defense; and for other purposes." NSF makes every effort to conduct a fair, competitive, transparent merit review process for the selection of projects.

## 1. Merit Review Principles

These principles are to be given due diligence by PIs and organizations when preparing proposals and managing projects, by reviewers when reading and evaluating proposals, and by NSF program staff when determining whether or not to recommend proposals for funding and while overseeing awards. Given that NSF is the primary federal agency charged with nurturing and supporting excellence in basic research and education, the following three principles apply:

All NSF projects should be of the highest quality and have the potential to advance, if not transform, the frontiers
of knowledge.

- NSF projects, in the aggregate, should contribute more broadly to achieving societal goals. These "Broader Impacts" may be accomplished through the research itself, through activities that are directly related to specific research projects, or through activities that are supported by, but are complementary to, the project. The project activities may be based on previously established and/or innovative methods and approaches, but in either case must be well justified.
- Meaningful assessment and evaluation of NSF funded projects should be based on appropriate metrics, keeping
  in mind the likely correlation between the effect of broader impacts and the resources provided to implement
  projects. If the size of the activity is limited, evaluation of that activity in isolation is not likely to be meaningful.
  Thus, assessing the effectiveness of these activities may best be done at a higher, more aggregated, level than the
  individual project.

With respect to the third principle, even if assessment of Broader Impacts outcomes for particular projects is done at an aggregated level, PIs are expected to be accountable for carrying out the activities described in the funded project. Thus, individual projects should include clearly stated goals, specific descriptions of the activities that the PI intends to do, and a plan in place to document the outputs of those activities.

These three merit review principles provide the basis for the merit review criteria, as well as a context within which the users of the criteria can better understand their intent.

#### 2. Merit Review Criteria

All NSF proposals are evaluated through use of the two National Science Board approved merit review criteria. In some instances, however, NSF will employ additional criteria as required to highlight the specific objectives of certain programs and activities.

The two merit review criteria are listed below. **Both** criteria are to be given **full consideration** during the review and decision-making processes; each criterion is necessary but neither, by itself, is sufficient. Therefore, proposers must fully address both criteria. (PAPPG Chapter II.D.2.d(i). contains additional information for use by proposers in development of the Project Description section of the proposal). Reviewers are strongly encouraged to review the criteria, including PAPPG Chapter II.D.2.d(i), prior to the review of a proposal.

When evaluating NSF proposals, reviewers will be asked to consider what the proposers want to do, why they want to do it, how they plan to do it, how they will know if they succeed, and what benefits could accrue if the project is successful. These issues apply both to the technical aspects of the proposal and the way in which the project may make broader contributions. To that end, reviewers will be asked to evaluate all proposals against two criteria:

- Intellectual Merit: The Intellectual Merit criterion encompasses the potential to advance knowledge; and
- **Broader Impacts:** The Broader Impacts criterion encompasses the potential to benefit society and contribute to the achievement of specific, desired societal outcomes.

The following elements should be considered in the review for both criteria:

- 1. What is the potential for the proposed activity to
  - a. Advance knowledge and understanding within its own field or across different fields (Intellectual Merit); and
  - b. Benefit society or advance desired societal outcomes (Broader Impacts)?
- 2. To what extent do the proposed activities suggest and explore creative, original, or potentially transformative concepts?
- 3. Is the plan for carrying out the proposed activities well-reasoned, well-organized, and based on a sound rationale? Does the plan incorporate a mechanism to assess success?
- 4. How well qualified is the individual, team, or organization to conduct the proposed activities?

5. Are there adequate resources available to the PI (either at the home organization or through collaborations) to carry out the proposed activities?

Broader impacts may be accomplished through the research itself, through the activities that are directly related to specific research projects, or through activities that are supported by, but are complementary to, the project. NSF values the advancement of scientific knowledge and activities that contribute to achievement of societally relevant outcomes. Such outcomes include, but are not limited to: full participation of women, persons with disabilities, and other underrepresented groups in science, technology, engineering, and mathematics (STEM); improved STEM education and educator development at any level; increased public scientific literacy and public engagement with science and technology; improved well-being of individuals in society; development of a diverse, globally competitive STEM workforce; increased partnerships between academia, industry, and others; improved national security; increased economic competitiveness of the United States; and enhanced infrastructure for research and education.

Proposers are reminded that reviewers will also be asked to review the Data Management and Sharing Plan and the Mentoring Plan, as appropriate.

#### **B. Review and Selection Process**

Proposals submitted in response to this program solicitation will be reviewed by Ad hoc Review and/or Panel Review.

Reviewers will be asked to evaluate proposals using two National Science Board approved merit review criteria and, if applicable, additional program specific criteria. A summary rating and accompanying narrative will generally be completed and submitted by each reviewer and/or panel. The Program Officer assigned to manage the proposal's review will consider the advice of reviewers and will formulate a recommendation.

After scientific, technical and programmatic review and consideration of appropriate factors, the NSF Program Officer recommends to the cognizant Division Director whether the proposal should be declined or recommended for award. NSF strives to be able to tell proposers whether their proposals have been declined or recommended for funding within six months. Large or particularly complex proposals or proposals from new recipients may require additional review and processing time. The time interval begins on the deadline or target date, or receipt date, whichever is later. The interval ends when the Division Director acts upon the Program Officer's recommendation.

After programmatic approval has been obtained, the proposals recommended for funding will be forwarded to the Division of Grants and Agreements or the Division of Acquisition and Cooperative Support for review of business, financial, and policy implications. After an administrative review has occurred, Grants and Agreements Officers perform the processing and issuance of a grant or other agreement. Proposers are cautioned that only a Grants and Agreements Officer may make commitments, obligations or awards on behalf of NSF or authorize the expenditure of funds. No commitment on the part of NSF should be inferred from technical or budgetary discussions with a NSF Program Officer. A Principal Investigator or organization that makes financial or personnel commitments in the absence of a grant or cooperative agreement signed by the NSF Grants and Agreements Officer does so at their own risk.

Once an award or declination decision has been made, Principal Investigators are provided feedback about their proposals. In all cases, reviews are treated as confidential documents. Verbatim copies of reviews, excluding the names of the reviewers or any reviewer-identifying information, are sent to the Principal Investigator/Project Director by the Program Officer. In addition, the proposer will receive an explanation of the decision to award or decline funding.

#### VII. Award Administration Information

## A. Notification of the Award

Notification of the award is made to *the submitting organization* by an NSF Grants and Agreements Officer. Organizations whose proposals are declined will be advised as promptly as possible by the cognizant NSF Program administering the program. Verbatim copies of reviews, not including the identity of the reviewer, will be provided automatically to the Principal Investigator. (See Section VI.B. for additional information on the review process.)

#### **B. Award Conditions**

An NSF award consists of: (1) the award notice, which includes any special provisions applicable to the award and any numbered amendments thereto; (2) the budget, which indicates the amounts, by categories of expense, on which NSF has based its support (or otherwise communicates any specific approvals or disapprovals of proposed expenditures); (3) the proposal referenced in the award notice; (4) the applicable award conditions, such as Grant General Conditions (GC-1)\*; and (5) any announcement or other NSF issuance that may be incorporated by reference in the award notice. Cooperative agreements also are administered in accordance with NSF Cooperative Agreement Financial and Administrative Terms and Conditions (CA-FATC) and the applicable Programmatic Terms and Conditions. NSF awards are electronically signed by an NSF Grants and Agreements Officer and transmitted electronically to the organization via e-mail.

#### **Build America, Buy America**

As expressed in Executive Order 14005, Ensuring the Future is Made in All of America by All of America's Workers (86 FR 7475), it is the policy of the executive branch to use terms and conditions of Federal financial assistance awards to maximize, consistent with law, the use of goods, products, and materials produced in, and services offered in, the United States.

#### **C. Reporting Requirements**

For all multi-year grants (including both standard and continuing grants), the Principal Investigator must submit an annual project report to the cognizant Program Officer no later than 90 days prior to the end of the current budget period. (Some programs or awards require submission of more frequent project reports). No later than 120 days following expiration of a grant, the PI also is required to submit a final annual project report, and a project outcomes report for the general public.

Failure to provide the required annual or final annual project reports, or the project outcomes report, will delay NSF review and processing of any future funding increments as well as any pending proposals for all identified PIs and co-PIs on a given award. PIs should examine the formats of the required reports in advance to assure availability of required data.

Pls are required to use NSF's electronic project-reporting system, available through Research.gov, for preparation and submission of annual and final annual project reports. Such reports provide information on accomplishments, project participants (individual and organizational), publications, and other specific products and impacts of the project. Submission of the report via Research.gov constitutes certification by the PI that the contents of the report are accurate and complete. The project outcomes report also must be prepared and submitted using Research.gov. This report serves as a brief summary, prepared specifically for the public, of the nature and outcomes of the project. This report will be posted on the NSF website exactly as it is submitted by the PI.
