IMPORTANT INFORMATION AND REVISION NOTES

A revised version of the *NSF Proposal & Award Policies & Procedures Guide* (PAPPG), *NSF* 13-1, was issued on October 4, 2012 and is effective for proposals submitted, or due, on or after January 14, 2013. Please be advised that the guidelines contained in *NSF* 13-1 apply to proposals submitted in response to this funding opportunity.

Please be aware that significant changes have been made to the PAPPG to implement revised merit review criteria based on the National Science Board (NSB) report, National Science Foundation's Merit Review Criteria: Review and Revisions. While the two merit review criteria remain unchanged (Intellectual Merit and Broader Impacts), guidance has been provided to clarify and improve the function of the criteria. Changes will affect the project summary and project description sections of proposals. Annual and final reports also will be affected.

A by-chapter summary of this and other significant changes is provided at the beginning of both the *Grant Proposal Guide* and the *Award & Administration Guide*.

Please note that this program solicitation may contain supplemental proposal preparation guidance and/or guidance that deviates from the guidelines established in the Grant Proposal Guide.

Synopsis of Program:

The Hydrologic Sciences Program focuses on the fluxes of water in the environment that constitute the water cycle as well as the mass and energy transport function of the water cycle in the environment. The Program supports studying processes from rainfall to runoff to infiltration and streamflow; evaporation and transpiration; as well as the flow of water in soils and aquifers and the transport of suspended, dissolved and colloidal components. Water is seen as the mode of coupling among various components of the environment and emphasis is placed on how the coupling is enabled by the water cycle and how it functions as a process. The Hydrologic Sciences Program retains a strong focus on linking the fluxes of water and the components carried by water across the boundaries between various interacting components of the terrestrial system and the mechanisms by which these fluxes coorganize over a variety of timescales and/or alter the fundamentals of the interacting components. The Program is also interested in how water interacts with the solid phase, the landscape and the ecosystem as well as how such interactions and couplings are altered by land use and climate change. Studies may address aqueous geochemistry and solid phase interactions as well as physical, chemical, and biological processes as coupled to water transport. These studies commonly involve expertise from basic sciences and mathematics, and proposals may require joint review with related programs. The Hydrologic Sciences Program will also consider some synthesis activities.

I. INTRODUCTION

The Hydrologic Sciences Program is part of the Surface Earth Processes (SEP) Section of the Division of Earth Sciences (EAR). EAR provides funding for the conduct of research concerning the solid Earth and its surface environment. In addition, EAR provides some support for instrumental and observational infrastructure, cyberinfrastructure, and innovative educational and outreach activities. Projects may employ combinations of field, laboratory, and computational studies with observational, theoretical, modelling or experimental approaches. Support is available for research, synthesis research and research infrastructure through grants, contracts, and cooperative agreements awarded in response to investigator-initiated proposals from U.S. universities and other eligible organizations. EAR will consider co-funding of projects with other agencies and supports international work and collaborations.

II. PROGRAM DESCRIPTION

The Hydrologic Sciences Program focuses on the fluxes of water in the environment that constitute the water cycle as well as the mass and energy transport function of the water cycle in the environment. The Program supports studying processes of rainfall to runoff to infiltration and streamflow; evaporation and transpiration; as well as the flow of water in soils and aquifers and the transport of suspended, dissolved and colloidal components. The Hydrological Sciences Program retains strong emphasis on linking the fluxes of water and the components carried by water across boundaries between various interacting components of the terrestrial system and the mechanisms by which these fluxes co-organize over a variety of timescales and/or alter the fundamentals of the interacting components. Water is seen as the mode of coupling among various components of the environment and emphasis is placed on how the coupling is enabled and how it functions as a process. Topics may be investigated as deterministic or stochastic processes by observational, experimental or modeling approaches. The program supports studies examining (1) the spatial and temporal heterogeneity of water and chemical fluxes and storages from local to global scales, (2) interfacial water fluxes and pathways among system compartments; and (3) how hydrologic processes couple to the critical zone via land use change, climate change and ecosystems function. Hydrologic Sciences also supports research in aqueous, colloidal and suspended geochemistry directly connected to hydrologic transport processes. Since the study of hydrologic processes requires expertise from basic sciences, engineering and mathematics, Hydrologic Sciences encourages interdisciplinary proposals and provides joint review with related programs.

This context for the Hydrologic Sciences Program is based on the National Academy of Sciences (2012) report entitled "Challenges and Opportunities in the Hydrologic Sciences" as well as many other documents including "Basic Research Opportunities in Earth Science" (NAS, 2001); "New Research Opportunities in the Earth Sciences" (2012) and "Geovision Report (NSF, 2009). These documents identify multiple questions whose answers are central to the understanding the temporal and spatial variability of the water cycle across Earth's landscapes. Additionally, the context in which these questions are presented, emphasizes the key role of hydrology for understanding the function of environmental systems and the complex interactions of nature, climate and anthropogenic processes.

The Hydrologic Sciences Program is committed to supporting the most meritorious research in relevant areas, including interdisciplinary and multidisciplinary research, as well as research involving international collaboration. The Program is interested in proposals in emerging fields and insights into the role and function of water in the environment and its operation within the critical zone at all time and space sales. Where appropriate, proposals may be considered for joint support with other programs in EAR, GEO or with other Directorates at the National Science Foundation. Proposals may be transferred to other programs within EAR or to other Directorates within the National Science Foundation when it is deemed appropriate by Program Officers from the respective programs. Principal Investigators are encouraged to contact the cognizant program officers regarding proposals that may cross programmatic boundaries before submission.

Transformational Opportunities

Hydrologic Sciences accepts proposals that will contribute to the transformation of hydrologic knowledge and research methodologies. The Program is interested in research that meet the following criteria: (1) fills identified knowledge gaps in hydrology, and (2) poses fundamental new questions about the role and function of water in the critical zone system and (3) will provide answers to those fundamental questions. Hydrologic Sciences is also interested in scaling analysis, systems analysis, hydrologic systems modeling studies (on all scales) and observational, experimental, theoretical, modelling or field studies that elucidate sensitivity, feedback loops and thresholds of environmental systems coupled through the flow and transport mediated by the water cycle. Such studies are expected to be at a fundamental level and should also be smaller (see budget guidance) in scope than is supported by larger multi-Directorate solicitations. Interdisciplinary teams considering submitting proposals are encouraged to contact the cognizant Program Officer with an expression of interest and to communicate their anticipated needs before proceeding with proposal development.

Hydrologic Sciences will also consider some projects in synthesis that hold promise to significantly advance hydrologic science and the understanding of hydrologic couplings to the critical zone environment. Synthesis activities should be at a level appropriate to the scope and funding of the program. Synthesis activities are expected to be a part of the overall effort in hydrology although field, laboratory and computational hydrology remain the core focus.

Hydrologic Sciences is not interested in case studies that examine site specific problems where knowledge gained will have only limited transferable value. The Hydrologic Sciences Program does not support applied studies where the results will only have specific application to specific sites. The Hydrologic Sciences Program does acknowledge that the study of specific hydrologic questions requires a site and that the results may have direct applications yet that is considered a positive aspect only under the realm of broader impact and not intellectual merit. The principle focus of proposals submitted to the Hydrologic Sciences Program should be advancing knowledge with regard to hydrologic process and function.

III. AWARD INFORMATION

Anticipated funding is \$10,000,000, annually. The estimated number of awards is 25 to 35 standard or continuing grants or cooperative agreements per year. Awards are generally made within 6 to 7 months of the proposal submission date for successful proposals.

Estimated program budget, number of awards and average award size/duration are subject to the availability of funds. Regular research awards supported by HS are generally but not exclusively in the range of \$250,000 to \$700,000 and of 2-4 years duration. Hydrologic process synthesis projects should be at a level appropriate to the scope of topic and are expected to be conducted at total levels of <\$1,000,000 over 3-5 years with an emphasis on support of graduate students and postdocs.

EAR Data Policy: Principal investigators are required to adhere to the EAR Data Policy available on the NSF website (http://www.nsf.gov/geo/ear/2010EAR_data_policy_9_28_10.pdf). Proposals should include a statement describing how the data policy requirements will be met.

Wherever possible, data should be lodged with established data centers utilizing the most appropriate formats and ontologies. For many hydrologic sciences projects, this can be accomplished within e.g. CUAHSI-HIS, EarthChem and DataOne yet it is acknowledged that not all data can be accommodated by these protocols. When data are not directly deposited with established catalogues, data should be registered with such catalogs to ensure the highest probability for discover via various searches. Final reports for all awards should include a statement describing how the data policy requirements have been met.

Projects involving work in foreign countries: Projects involving work in foreign countries: For studies in countries other than the United States, the project description should discuss, where appropriate, collaborations with scientists and students from the host country, and how these individuals will be involved in the project. Collaborations should be well justified, in that they represent true intellectual collaboration and utilize the expertise and specialized skills, facilities, and/or resources of the foreign collaborator. Letters of collaboration must be included in the Special Information and Supplementary Documents section of the proposal. These letters should include a discussion of the role of the collaborator in the project and the resources the collaborating foreign institution/organization will provide to the project. Principal investigators are encouraged to provide U.S. students and junior researchers with international research experiences. An important provision of Grant Proposal Guide (Sec II.C.2.j) states "some governments require nonresidents to obtain official approval to carry out investigations within their borders and coastal waters under their jurisdiction. Pls are responsible for obtaining the required authorizations and for advising NSF that they have been obtained or requested." Failure to obtain the appropriate permits for all aspects of the research effort may jeopardize not only the proposed research, but also the well-being of the personnel. Where relevant, arrangements to allocate samples and data between host country organization(s) or institution(s) and U.S. organization(s) or institution(s) should be discussed in the proposal. Investigators are encouraged to include any such permits (including legally required collecting, import, and export permits for samples, instrumentation, and data), authorizations, and agreements, in the Special Information and Supplementary Documents section of the proposal.

Equipment requests in excess of \$50,000 usually require a separate proposal directly to the Instrumentation and Facilities Program. However, equipment requests of less than \$50,000 that are unassociated with specific research proposals may be submitted to the Instrumentation and Facilities Program. Investigators planning on submitting an EAR research proposal with a significant equipment budget are encouraged to discuss these plans with the relevant research program officer prior to submission.

VI. NSF PROPOSAL PROCESSING AND REVIEW PROCEDURES

Proposals received by NSF are assigned to the appropriate NSF program for acknowledgement and, if they meet NSF requirements, for review. All proposals are carefully reviewed by a scientist, engineer, or educator serving as an NSF Program Officer, and usually by three to ten other persons outside NSF either as *ad hoc* reviewers, panelists, or both, who are experts in the particular fields represented by the proposal. These reviewers are selected by Program Officers charged with oversight of the review process. Proposers are invited to suggest names of persons they believe are especially well qualified to review the proposal and/or persons they would prefer not review the proposal. These suggestions may serve as one source in the reviewer selection process at the Program Officer's discretion. Submission of such names, however, is optional. Care is taken to ensure that reviewers have no conflicts of interest with the proposal. In addition, Program Officers may obtain comments from site visits before recommending final action on proposals. Senior NSF staff further review recommendations for awards. A flowchart that depicts the entire NSF proposal and award process (and associated timeline) is included in the GPG as Exhibit III-1.

Proposers should also be aware of core strategies that are essential to the fulfillment of NSF's mission, as articulated in *Empowering the Nation Through Discovery and Innovation: NSF Strategic Plan for Fiscal Years (FY) 2011-2016.* These strategies are integrated in the program planning and implementation process, of which proposal review is one part. NSF's mission is particularly well-implemented through the integration of research and education and broadening participation in NSF programs, projects, and activities.

One of the core strategies in support of NSF's mission is to foster integration of research and education through the programs, projects and activities it supports at academic and research institutions. These institutions provide abundant opportunities where individuals may concurrently assume responsibilities as researchers, educators, and students, and where all can engage in joint efforts that infuse education with the excitement of discovery and enrich research through the variety of learning perspectives.

Another core strategy in support of NSF's mission is broadening opportunities and expanding participation of groups, institutions, and geographic regions that are underrepresented in STEM disciplines, which is essential to the health and vitality of science and engineering. NSF is committed to this principle of diversity and deems it central to the programs, projects, and activities it considers and supports.

The National Science Foundation strives to invest in a robust and diverse portfolio of projects that creates new knowledge and enables breakthroughs in understanding across all areas of science and engineering research and education. To identify which projects to support, NSF relies on a merit review process that incorporates consideration of both the technical aspects of a proposed project and its potential to contribute more broadly to advancing NSF's mission "to promote the progress of science; to advance the national health, prosperity, and welfare; to secure the national defense; and for other purposes." NSF makes every effort to conduct a fair, competitive, transparent merit review process for the selection of projects.

1. Merit Review Principles

These principles are to be given due diligence by PIs and organizations when preparing proposals and managing projects, by reviewers when reading and evaluating proposals, and by NSF program staff when determining whether or not to recommend proposals for funding and while overseeing awards. Given that NSF is the primary federal agency charged with nurturing and supporting excellence in basic research and education, the following three principles apply:

- · All NSF projects should be of the highest quality and have the potential to advance, if not transform, the frontiers of knowledge.
- NSF projects, in the aggregate, should contribute more broadly to achieving societal goals. These "Broader Impacts" may be accomplished through the research itself, through activities that are directly related to specific research projects, or through activities that are supported by, but are complementary to, the project. The project activities may be based on previously established and/or innovative methods and approaches, but in either case must be well justified.
- Meaningful assessment and evaluation of NSF funded projects should be based on appropriate metrics, keeping in mind the likely correlation between the effect of broader impacts and the resources provided to implement projects. If the size of the activity is limited, evaluation of that activity in isolation is not likely to be meaningful. Thus, assessing the effectiveness of these activities may best be done at a higher, more aggregated, level than the individual project.

With respect to the third principle, even if assessment of Broader Impacts outcomes for particular projects is done at an aggregated level, PIs are expected to be accountable for carrying out the activities described in the funded project. Thus, individual projects should include clearly stated goals, specific descriptions of the activities that the PI intends to do, and a plan in place to document the outputs of those activities.

These three merit review principles provide the basis for the merit review criteria, as well as a context within which the users of the criteria can better understand their intent.

2. Merit Review Criteria

All NSF proposals are evaluated through use of the two National Science Board approved merit review criteria. In some instances, however, NSF will employ additional criteria as required to highlight the specific objectives of certain programs and activities.

The two merit review criteria are listed below. Both criteria are to be given full consideration during the review and decisionmaking processes; each criterion is necessary but neither, by itself, is sufficient. Therefore, proposers must fully address both criteria. (GPG Chapter II.C.2.d.i. contains additional information for use by proposers in development of the Project Description section of the proposal.) Reviewers are strongly encouraged to review the criteria, including GPG Chapter II.C.2.d.i., prior to the review of a proposal.

When evaluating NSF proposals, reviewers will be asked to consider what the proposers want to do, why they want to do it, how they plan to do it, how they will know if they succeed, and what benefits could accrue if the project is successful. These issues apply both to the technical aspects of the proposal and the way in which the project may make broader contributions. To that end, reviewers will be asked to evaluate all proposals against two criteria:

- · Intellectual Merit: The Intellectual Merit criterion encompasses the potential to advance knowledge; and
- Broader Impacts: The Broader Impacts criterion encompasses the potential to benefit society and contribute to the achievement of specific, desired societal outcomes.

The following elements should be considered in the review for both criteria:

- 1. What is the potential for the proposed activity to
 - a. Advance knowledge and understanding within its own field or across different fields (Intellectual Merit); and b. Benefit society or advance desired societal outcomes (Broader Impacts)?
- 2. To what extent do the proposed activities suggest and explore creative, original, or potentially transformative concepts?
- 3. Is the plan for carrying out the proposed activities well-reasoned, well-organized, and based on a sound rationale? Does the plan incorporate a mechanism to assess success?
- How well qualified is the individual, team, or organization to conduct the proposed activities?
 Are there adequate resources available to the PI (either at the home organization or through collaborations) to carry out the proposed activities?

Broader impacts may be accomplished through the research itself, through the activities that are directly related to specific research projects, or through activities that are supported by, but are complementary to, the project. NSF values the advancement of scientific knowledge and activities that contribute to achievement of societally relevant outcomes. Such outcomes include, but are not limited to: full participation of women, persons with disabilities, and underrepresented minorities in science, technology, engineering, and mathematics (STEM); improved STEM education and educator development at any level; increased public scientific literacy and public engagement with science and technology; improved well-being of individuals in society; development of a diverse, globally competitive STEM workforce; increased partnerships between academia, industry, and others; improved national security; increased economic competitiveness of the United States; and enhanced infrastructure for research and education.

Proposers are reminded that reviewers will also be asked to review the Data Management Plan and the Postdoctoral Researcher Mentoring Plan, as appropriate.

B. Review and Selection Process

Proposals submitted in response to this program solicitation will be reviewed by Ad hoc Review and/or Panel Review.

Reviewers will be asked to formulate a recommendation to either support or decline each proposal. The Program Officer assigned to manage the proposal's review will consider the advice of reviewers and will formulate a recommendation.

After scientific, technical and programmatic review and consideration of appropriate factors, the NSF Program Officer recommends to the cognizant Division Director whether the proposal should be declined or recommended for award. NSF is striving to be able to tell applicants whether their proposals have been declined or recommended for funding within six months. The time interval begins on

the deadline or target date, or receipt date, whichever is later. The interval ends when the Division Director accepts the Program Officer's recommendation.

A summary rating and accompanying narrative will be completed and submitted by each reviewer. In all cases, reviews are treated as confidential documents. Verbatim copies of reviews, excluding the names of the reviewers, are sent to the Principal Investigator/Project Director by the Program Officer. In addition, the proposer will receive an explanation of the decision to award or decline funding.

In all cases, after programmatic approval has been obtained, the proposals recommended for funding will be forwarded to the Division of Grants and Agreements for review of business, financial, and policy implications and the processing and issuance of a grant or other agreement. Proposers are cautioned that only a Grants and Agreements Officer may make commitments, obligations or awards on behalf of NSF or authorize the expenditure of funds. No commitment on the part of NSF should be inferred from technical or budgetary discussions with a NSF Program Officer. A Principal Investigator or organization that makes financial or personnel commitments in the absence of a grant or cooperative agreement signed by the NSF Grants and Agreements Officer does so at their own risk.

VII. AWARD ADMINISTRATION INFORMATION

A. Notification of the Award

Notification of the award is made to *the submitting organization* by a Grants Officer in the Division of Grants and Agreements. Organizations whose proposals are declined will be advised as promptly as possible by the cognizant NSF Program administering the program. Verbatim copies of reviews, not including the identity of the reviewer, will be provided automatically to the Principal Investigator. (See Section VI.B. for additional information on the review process.)

B. Award Conditions

An NSF award consists of: (1) the award letter, which includes any special provisions applicable to the award and any numbered amendments thereto; (2) the budget, which indicates the amounts, by categories of expense, on which NSF has based its support (or otherwise communicates any specific approvals or disapprovals of proposed expenditures); (3) the proposal referenced in the award letter; (4) the applicable award conditions, such as Grant General Conditions (GC-1); * or Research Terms and Conditions * and (5) any announcement or other NSF issuance that may be incorporated by reference in the award letter. Cooperative agreements also are administered in accordance with NSF Cooperative Agreement Financial and Administrative Terms and Conditions (CA-FATC) and the applicable Programmatic Terms and Conditions. NSF awards are electronically signed by an NSF Grants and Agreements Officer and transmitted electronically to the organization via e-mail.

C. Reporting Requirements

For all multi-year grants (including both standard and continuing grants), the Principal Investigator must submit an annual project report to the cognizant Program Officer at least 90 days prior to the end of the current budget period. (Some programs or awards require submission of more frequent project reports). Within 90 days following expiration of a grant, the PI also is required to submit a final project report, and a project outcomes report for the general public.

Failure to provide the required annual or final project reports, or the project outcomes report, will delay NSF review and processing of any future funding increments as well as any pending proposals for all identified PIs and co-PIs on a given award. PIs should examine the formats of the required reports in advance to assure availability of required data.

Pls are required to use NSF's electronic project-reporting system, available through Research.gov, for preparation and submission of annual and final project reports. Such reports provide information on accomplishments, project participants (individual and organizational), publications, and other specific products and impacts of the project. Submission of the report via Research.gov constitutes certification by the PI that the contents of the report are accurate and complete. The project outcomes report also must be prepared and submitted using Research.gov. This report serves as a brief summary, prepared specifically for the public, of the nature and outcomes of the project. This report will be posted on the NSF website exactly as it is submitted by the PI.

EAR Data Policy: Principal investigators are required to adhere to the EAR Data Policy available on the NSF website. Final reports for all awards should include a statement describing how the data policy requirements have been met.

Wherever possible, data should be lodged with established data centers utilizing the most appropriate formats and ontologies. For many hydrologic sciences projects, this can be accomplished within e.g. CUAHSI-HIS, EarthChem and DataOne yet it is acknowledged that not all data can be accommodated by these protocols. When data are not directly deposited with established catalogues, data should be registered with such catalogs to ensure the highest probability for discover via various searches. Final reports for all awards should include a statement describing how the data policy requirements have been met.
