The Hydrologic Sciences Program supports basic research on the fluxes of water in the terrestrial environment that constitute the water cycle as well as the mass and energy transport function of the water cycle. The Program supports the study of processes including (but not limited to): rainfall, runoff, infiltration and streamflow; evaporation and transpiration; the flow of water in soils and aquifers; and the transport of suspended, dissolved, and colloidal components. The Program is interested in how water interacts with the landscape and the ecosystem as well as how the water cycle and its coupled processes are altered by land use and climate. Studies may address physical, chemical, and/or biological processes that are coupled directly to water transport. Observational, experimental, theoretical, modeling, synthesis and field approaches are supported. Projects submitted to Hydrologic Sciences commonly involve expertise from physical and ecosystem sciences, engineering and/or mathematics; and proposals may require joint review with related programs.

## **I. INTRODUCTION**

---

The Hydrologic Sciences Program supports basic research on the fluxes of water in the environment that constitute the water cycle as well as the mass and energy transport function of the water cycle. The Program supports the study of processes including (but not limited to): rainfall, runoff, infiltration and streamflow; evaporation and transpiration; the flow of water in soils and aquifers; and the transport of suspended, dissolved and colloidal components. The Program is interested in how water interacts with the landscape and the ecosystem as well as how the water cycle and its coupled processes are altered by land use and climate. Observational, experimental, theoretical, modeling, synthesis and field approaches are supported.

## **II. PROGRAM DESCRIPTION**

---

The Hydrological Sciences Program focuses on linking the fluxes of water and the components carried by water across boundaries between interacting components of the terrestrial system, as well as the mechanisms by which these fluxes co-organize over a variety of temporal and spatial scales. The Program is interested in how hydrologic processes couple to and interact with the critical zone, the landscape and the ecosystem, as well as how the water cycle and its coupled processes are altered by land use and climate. Studies may address physical, chemical, and/or biological processes that are coupled directly to water transport.

The Hydrologic Sciences Program is committed to supporting the most meritorious research in any relevant area, including interdisciplinary and multidisciplinary research, and is especially interested in proposals in emerging fields, and those that are responsive to recent reports from the hydrologic sciences community. At this time, the Hydrologic Sciences Program is particularly (but not exclusively) interested in: how hydrologic processes are altered in human-impacted waterscapes; hydrologic response to global change; advancing our capabilities in integrated hydrologic systems modeling (from pore to continental scales); applications of data science to advance hydrologic sciences (e.g. data fusion and hydroinformatics; hydrologic data mining and machine learning); leveraging advances in remote sensing and hydrologic modeling to understand processes at continental to global scales; and interactions between hydrologic and ecologic systems. The Hydrologic Sciences Program is also interested in developing collaborative research with federal agency partners and leveraging capabilities of NSF-supported facilities. Because the study of hydrologic processes may require expertise from other physical sciences, ecosystem science, engineering and/or mathematics, the program encourages interdisciplinary proposals and conducts joint review with related programs across the NSF (e.g. Geomorphology & Land Use Dynamics; Geobiology & Low-Temperature Geochemistry; Geophysics; Physical & Dynamic Meteorology; Chemical Oceanography; Geography & Spatial Science; Environmental Engineering; Ecosystems Studies). Projects supported by the disciplinary Hydrologic Sciences Program should be smaller in scope (see budget guidance) than is supported by larger multi-Directorate solicitations. Where appropriate, proposals may be considered for joint support with other programs in the Division of Earth Sciences and/or with other Divisions at the National Science Foundation. In some cases, proposals may be transferred to other programs across the National Science Foundation when it is deemed appropriate by Program Officers from the respective programs or divisions. Interdisciplinary teams are strongly encouraged to contact the cognizant program officers in all relevant programs regarding proposals that may cross disciplinary boundaries before submission.

All Hydrologic Sciences projects are expected to meet NSF's broader impacts review criteria by discussing the impacts of the project proposed on society (see PAPPG Chapter III). The Hydrologic Sciences Program seeks projects that attract students and involve early career researchers. Successful projects will include creative, integrative, and effective broader impact activities developed within the context of the mission, goals, and resources of the organizations involved. Broader impacts activities must be an integral part of the proposed research and this should be reflected in the expertise of collaborators, the proposal budget, and budget justification.

Collaborative projects should include a clear project management plan to involve all collaborators, a task list for completion of the project and a timeline for accomplishing the project. Involvement of early career scientists and cross disciplinary training in collaborative projects is strongly encouraged.

All non-standard proposals, such as RAPID and conference proposals, must be discussed with a Program Director prior to submission.

**Collaborative Proposals.** All collaborative proposals submitted as separate submissions from multiple organizations must be submitted via FastLane or Research.gov. PAPPG Chapter II.D.3 provides additional information on collaborative proposals.

See PAPPG Chapter II.C.2 for guidance on the required sections of a full research proposal submitted to NSF. Please note that the proposal preparation instructions provided in this program solicitation may deviate from the PAPPG instructions.

**The following instructions supplement the PAPPG and the NSF Grants.gov Application Guide:**

**EAR Data Policy:** Principal investigators are required to adhere to the [EAR Data Policy](#) available on the NSF website. Proposals should include a statement describing how the data policy requirements will be met. Wherever possible, data should be lodged with established data centers utilizing the most appropriate formats and ontologies. For many hydrologic sciences projects, this can be accomplished within CUAHSI Data Services, EarthChem, and DataOne. However, it is acknowledged that not all data can be accommodated by these protocols. When data are not directly deposited with established catalogues, data should be registered with such catalogs to ensure the highest probability for discovery via various searches. Final reports for all awards should include a statement describing how the data policy requirements have been met.

**RAPID Proposals:** Funding priority for RAPID proposals is for collection of perishable data. However, having an opportunity to collect perishable data is not the only criteria for RAPID proposal review; investigators must pose compelling scientific questions that motivate the data collection. Hydrologic Sciences typically does not fund RAPID proposals with budget requests exceeding \$50,000 and costs should directly support data acquisition only. Investigators should contact a Hydrologic Sciences Program Director regarding RAPID proposals before submission.

**Projects involving work in foreign countries:** Projects involving work in foreign countries: For studies in countries other than the United States, the project description should discuss, where appropriate, collaborations with scientists and students from the host country, and how these individuals will be involved in the project. Collaborations should be well justified, in that they represent true intellectual collaboration and utilize the expertise and specialized skills, facilities, and/or resources of the foreign collaborator. Letters of collaboration must be included in the Special Information and Supplementary Documents section of the proposal. These letters should include a discussion of the role of the collaborator in the project and the resources the collaborating foreign institution/organization will provide to the project. Principal investigators are encouraged to provide U.S. students and junior researchers with international research experiences. An important provision of the PAPPG ( Chapter II.D.8 ) states "some governments require nonresidents to obtain official approval to carry out investigations within their borders and coastal waters under their jurisdiction. PIs are responsible for obtaining the required authorizations." Failure to obtain the appropriate permits for all aspects of the research effort may jeopardize not only the proposed research, but also the well-being of the personnel. Where relevant, arrangements to allocate samples and data between host country organization(s) or institution(s) and U.S. organization(s) or institution(s) should be discussed in the proposal. Investigators are encouraged to include any such permits (including legally required collecting, import, and export permits for samples, instrumentation, and data), authorizations, and agreements, in the Special Information and Supplementary Documents section of the proposal.

**Projects with support from NSF-funded facilities:** For proposals that require support from centrally supported facilities, investigators must obtain letters of support from the managing organization agreeing to provide the needed facility resources described in the proposal and those letters should be included as a Supplementary Document. Such letters should follow the standard format of the managing organization; if no such format exists, the letters should adhere to the standard letter of collaboration required in the PAPPG.

**Research Experiences:** Projects anticipating the inclusion of REU, RET, or ROA activities should include those as part of the research proposal. Supplemental funding is intended only for unanticipated opportunities that arise during the course of the project.

#### Other Budgetary Limitations:

Equipment needs that can be demonstrably linked to the conduct of a specific research project being proposed to EAR may be included within the budget of the related research proposal. In general, equipment requests on proposals submitted to EAR research programs should not exceed a total of \$50,000. Equipment requests in excess of \$50,000 usually require a separate proposal directly to the Instrumentation and Facilities Program. However, equipment requests of less than \$50,000 that are unassociated with specific research proposals may be submitted to the Instrumentation and Facilities Program. Investigators planning on submitting an EAR research proposal with a significant equipment budget are encouraged to discuss these plans with the relevant research program officer prior to submission.

## VI. NSF PROPOSAL PROCESSING AND REVIEW PROCEDURES

---

Proposals received by NSF are assigned to the appropriate NSF program for acknowledgement and, if they meet NSF requirements, for review. All proposals are carefully reviewed by a scientist, engineer, or educator serving as an NSF Program Officer, and usually by three to ten other persons

outside NSF either as *ad hoc* reviewers, panelists, or both, who are experts in the particular fields represented by the proposal. These reviewers are selected by Program Officers charged with oversight of the review process. Proposers are invited to suggest names of persons they believe are especially well qualified to review the proposal and/or persons they would prefer not review the proposal. These suggestions may serve as one source in the reviewer selection process at the Program Officer's discretion. Submission of such names, however, is optional. Care is taken to ensure that reviewers have no conflicts of interest with the proposal. In addition, Program Officers may obtain comments from site visits before recommending final action on proposals. Senior NSF staff further review recommendations for awards. A flowchart that depicts the entire NSF proposal and award process (and associated timeline) is included in PAPPG Exhibit III-1.

Proposers should also be aware of core strategies that are essential to the fulfillment of NSF's mission, as articulated in *Building the Future: Investing in Discovery and Innovation - NSF Strategic Plan for Fiscal Years (FY) 2018 – 2022*. These strategies are integrated in the program planning and implementation process, of which proposal review is one part. NSF's mission is particularly well-implemented through the integration of research and education and broadening participation in NSF programs, projects, and activities.

One of the strategic objectives in support of NSF's mission is to foster integration of research and education through the programs, projects, and activities it supports at academic and research institutions. These institutions must recruit, train, and prepare a diverse STEM workforce to advance the frontiers of science and participate in the U.S. technology-based economy. NSF's contribution to the national innovation ecosystem is to provide cutting-edge research under the guidance of the Nation's most creative scientists and engineers. NSF also supports development of a strong science, technology, engineering, and mathematics (STEM) workforce by investing in building the knowledge that informs improvements in STEM teaching and learning.

NSF's mission calls for the broadening of opportunities and expanding participation of groups, institutions, and geographic regions that are underrepresented in STEM disciplines, which is essential to the health and vitality of science and engineering. NSF is committed to this principle of diversity and deems it central to the programs, projects, and activities it considers and supports.

## A. Merit Review Principles and Criteria

---

The National Science Foundation strives to invest in a robust and diverse portfolio of projects that creates new knowledge and enables breakthroughs in understanding across all areas of science and engineering research and education. To identify which projects to support, NSF relies on a merit review process that incorporates consideration of both the technical aspects of a proposed project and its potential to contribute more broadly to advancing NSF's mission "to promote the progress of science; to advance the national health, prosperity, and welfare; to secure the national defense; and for other purposes." NSF makes every effort to conduct a fair, competitive, transparent merit review process for the selection of projects.

### 1. Merit Review Principles

These principles are to be given due diligence by PIs and organizations when preparing proposals and managing projects, by reviewers when reading and evaluating proposals, and by NSF program staff when determining whether or not to recommend proposals for funding and while overseeing awards. Given that NSF is the primary federal agency charged with nurturing and supporting excellence in basic research and education, the following three principles apply:

- All NSF projects should be of the highest quality and have the potential to advance, if not transform, the frontiers of knowledge.
- NSF projects, in the aggregate, should contribute more broadly to achieving societal goals. These "Broader Impacts" may be accomplished through the research itself, through activities that are directly related to specific research projects, or through activities that are supported by, but are complementary to, the project. The project activities may be based on previously established and/or innovative methods and approaches, but in either case must be well justified.
- Meaningful assessment and evaluation of NSF funded projects should be based on appropriate metrics, keeping in mind the likely correlation between the effect of broader impacts and the resources provided to implement projects. If the size of the activity is limited, evaluation of that activity in isolation is not likely to be meaningful. Thus, assessing the effectiveness of these activities may best be done at a higher, more aggregated, level than the individual project.

With respect to the third principle, even if assessment of Broader Impacts outcomes for particular projects is done at an aggregated level, PIs are expected to be accountable for carrying out the activities described in the funded project. Thus, individual projects should include clearly stated goals, specific descriptions of the activities that the PI intends to do, and a plan in place to document the outputs of those activities.

These three merit review principles provide the basis for the merit review criteria, as well as a context within which the users of the criteria can better understand their intent.

### 2. Merit Review Criteria

All NSF proposals are evaluated through use of the two National Science Board approved merit review criteria. In some instances, however, NSF will employ additional criteria as required to highlight the specific objectives of certain programs and activities.

The two merit review criteria are listed below. **Both** criteria are to be given **full consideration** during the review and decision-making processes; each criterion is necessary but neither, by itself, is sufficient. Therefore, proposers must fully address both criteria. (PAPPG Chapter II.C.2.d(i), contains additional information for use by proposers in development of the Project Description section of the proposal). Reviewers are strongly encouraged to review the criteria, including PAPPG Chapter II.C.2.d(i), prior to the review of a proposal.

When evaluating NSF proposals, reviewers will be asked to consider what the proposers want to do, why they want to do it, how they plan to do it, how they will know if they succeed, and what benefits could accrue if the project is successful. These issues apply both to the technical aspects of the proposal and the way in which the project may make broader contributions. To that end, reviewers will be asked to evaluate all proposals against two criteria:

- **Intellectual Merit:** The Intellectual Merit criterion encompasses the potential to advance knowledge; and
- **Broader Impacts:** The Broader Impacts criterion encompasses the potential to benefit society and contribute to the achievement of specific, desired societal outcomes.

The following elements should be considered in the review for both criteria:

1. What is the potential for the proposed activity to
  - a. Advance knowledge and understanding within its own field or across different fields (Intellectual Merit); and
  - b. Benefit society or advance desired societal outcomes (Broader Impacts)?
2. To what extent do the proposed activities suggest and explore creative, original, or potentially transformative concepts?
3. Is the plan for carrying out the proposed activities well-reasoned, well-organized, and based on a sound rationale? Does the plan incorporate a mechanism to assess success?
4. How well qualified is the individual, team, or organization to conduct the proposed activities?
5. Are there adequate resources available to the PI (either at the home organization or through collaborations) to carry out the proposed activities?

Broader impacts may be accomplished through the research itself, through the activities that are directly related to specific research projects, or through activities that are supported by, but are complementary to, the project. NSF values the advancement of scientific knowledge and activities that contribute to achievement of societally relevant outcomes. Such outcomes include, but are not limited to: full participation of women, persons with disabilities, and underrepresented minorities in science, technology, engineering, and mathematics (STEM); improved STEM education and educator development at any level; increased public scientific literacy and public engagement with science and technology; improved well-being of individuals in society; development of a diverse, globally competitive STEM workforce; increased partnerships between academia, industry, and others; improved national security; increased economic competitiveness of the United States; and enhanced infrastructure for research and education.

Proposers are reminded that reviewers will also be asked to review the Data Management Plan and the Postdoctoral Researcher Mentoring Plan, as appropriate.

## **B. Review and Selection Process**

---

Proposals submitted in response to this program solicitation will be reviewed by Ad hoc Review and/or Panel Review.

Reviewers will be asked to evaluate proposals using two National Science Board approved merit review criteria and, if applicable, additional program specific criteria. A summary rating and accompanying narrative will generally be completed and submitted by each reviewer and/or panel. The Program Officer assigned to manage the proposal's review will consider the advice of reviewers and will formulate a recommendation.

After scientific, technical and programmatic review and consideration of appropriate factors, the NSF Program Officer recommends to the cognizant Division Director whether the proposal should be declined or recommended for award. NSF strives to be able to tell applicants whether their proposals have been declined or recommended for funding within six months. Large or particularly complex proposals or proposals from new awardees may require additional review and processing time. The time interval begins on the deadline or target date, or receipt date, whichever is later. The interval ends when the Division Director acts upon the Program Officer's recommendation.

After programmatic approval has been obtained, the proposals recommended for funding will be forwarded to the Division of Grants and Agreements for review of business, financial, and policy implications. After an administrative review has occurred, Grants and Agreements Officers perform the processing and issuance of a grant or other agreement. Proposers are cautioned that only a Grants and Agreements Officer may make commitments, obligations or awards on behalf of NSF or authorize the expenditure of funds. No commitment on the part of NSF should be inferred from technical or budgetary discussions with a NSF Program Officer. A Principal Investigator or organization that makes financial or personnel commitments in the absence of a grant or cooperative agreement signed by the NSF Grants and Agreements Officer does so at their own risk.

Once an award or declination decision has been made, Principal Investigators are provided feedback about their proposals. In all cases, reviews are treated as confidential documents. Verbatim copies of reviews, excluding the names of the reviewers or any reviewer-identifying information, are sent to the Principal Investigator/Project Director by the Program Officer. In addition, the proposer will receive an explanation of the decision to award or decline funding.

## **VII. AWARD ADMINISTRATION INFORMATION**

---

### **A. Notification of the Award**

---

Notification of the award is made to *the submitting organization* by a Grants Officer in the Division of Grants and Agreements. Organizations whose proposals are declined will be advised as promptly as possible by the cognizant NSF Program administering the program. Verbatim copies of reviews, not including the identity of the reviewer, will be provided automatically to the Principal Investigator. (See Section VI.B. for additional information on the review process.)

### **B. Award Conditions**

---

An NSF award consists of: (1) the award notice, which includes any special provisions applicable to the award and any numbered amendments thereto; (2) the budget, which indicates the amounts, by categories of expense, on which NSF has based its support (or otherwise communicates any specific approvals or disapprovals of proposed expenditures); (3) the proposal referenced in the award notice; (4) the applicable award conditions, such as Grant General Conditions (GC-1)\*; or Research Terms and Conditions\* and (5) any announcement or other NSF issuance that may be incorporated by reference in the award notice. Cooperative agreements also are administered in accordance with NSF Cooperative Agreement Financial and Administrative Terms and Conditions (CA-FATC) and the applicable Programmatic Terms and Conditions. NSF awards are electronically signed by an NSF Grants and Agreements Officer and transmitted electronically to the organization via e-mail.

## C. Reporting Requirements

---

For all multi-year grants (including both standard and continuing grants), the Principal Investigator must submit an annual project report to the cognizant Program Officer no later than 90 days prior to the end of the current budget period. (Some programs or awards require submission of more frequent project reports). No later than 120 days following expiration of a grant, the PI also is required to submit a final project report, and a project outcomes report for the general public.

Failure to provide the required annual or final project reports, or the project outcomes report, will delay NSF review and processing of any future funding increments as well as any pending proposals for all identified PIs and co-PIs on a given award. PIs should examine the formats of the required reports in advance to assure availability of required data.

PIs are required to use NSF's electronic project-reporting system, available through Research.gov, for preparation and submission of annual and final project reports. Such reports provide information on accomplishments, project participants (individual and organizational), publications, and other specific products and impacts of the project. Submission of the report via Research.gov constitutes certification by the PI that the contents of the report are accurate and complete. The project outcomes report also must be prepared and submitted using Research.gov. This report serves as a brief summary, prepared specifically for the public, of the nature and outcomes of the project. This report will be posted on the NSF website exactly as it is submitted by the PI.

**EAR Data Policy:** Principal investigators are required to adhere to the [EAR Data Policy](#) available on the NSF website. Proposals should include a statement describing how the data policy requirements will be met. Wherever possible, data should be lodged with established data centers utilizing the most appropriate formats and ontologies. For many hydrologic sciences projects, this can be accomplished within CUAHSI Data Services, EarthChem, and DataOne. However, it is acknowledged that not all data can be accommodated by these protocols. When data are not directly deposited with established catalogues, data should be registered with such catalogs to ensure the highest probability for discovery via various searches.

**Data Reporting Requirements:** Principal Investigators of Hydrologic Sciences awards are required to submit active hyperlinks to data and metadata files in the Final Project Report to NSF in the section entitled: Publications - Internet Dissemination. Principal investigators are strongly encouraged to utilize CUAHSI Data Services. Final reports for all awards should include a statement describing how the data policy requirements have been met.
